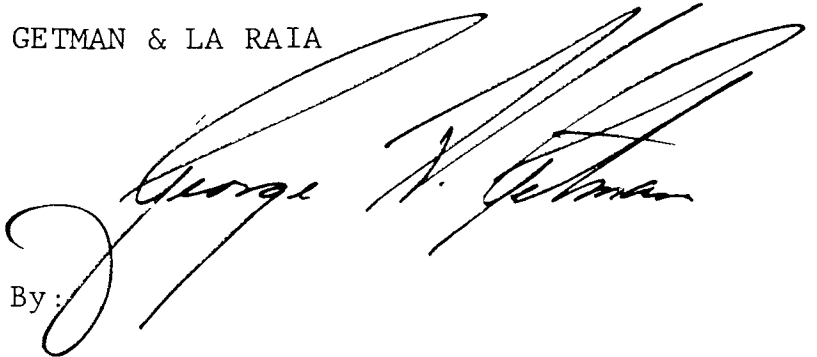
Enclosed is a notice of probate as required by statute,

publish and declare this my last Will and Testament, in manner following that
is to say:

FIRST. I hereby direct the payment by my Executor hereinafter named of all my just debts and funeral expenses, and all legitimate expenses incurred in the administration of my Estate.

FOURTH: All of the furniture owned by me at the time of my death, together with my jewelry, dishes, and household and personal effects, I give and bequeath unto my loving daughter, Nellie Lesko, to be hers, absolutely and forever.

FIFTH: All of the rest, residue and remainder of my Estate, whether real, personal or mixed, and wheresoever situate, including cash, I give, devise and bequeath in manner following:

Each of my following children are to share equally in the residue of my estate, Peter Sakowski, Nellie K.
